Introduction:

We, the undersigned external IQAC peer reviewers, were appointed by the vide resolution No. 1 of IQAC dated 26/02/2024 to assess and report on the progress of Swami Sahajanand College of Commerce & Management (SSCCM), Bhavnagar, at the end of its first year as an autonomous institution.

Being members of IQAC ourselves, we have been in constant touch with the college's academic and developmental activities, which has provided us with valuable insights

into its functioning and growth. Our visit on 18th August 2025 was conducted in accordance with UGC guidelines and keeping in mind the norms of the affiliating university and Uniform Model Statutes for The Gujarat Public Universities Act 2023.

The visit aimed to evaluate the implementation of autonomy, assess institutional preparedness for academic innovation, quality enhancement measures, and compliance with autonomy norms.

Institutional Overview:

SSCCM was conferred autonomy from the academic year 2024-25 for five years tenure. As a progressive institution with a focus on Commerce, Management, Arts and Computer Science Education, SSCCM has demonstrated a commitment to academic excellence, student-centric learning, and holistic development.

Key Observations:

Admission Policy:

Admissions at SSCCM for the year 2024-25 are conducted strictly on the basis of merit through the Gujarat Centralized Admission System (GCAS), as per the norms and guidelines prescribed by the Maharaja Krishnakumarsinhji University, Bhavnagar and the State Government. The entire process is transparent, online, and merit-driven, ensuring equal opportunity for all aspiring students. Candidates are required to register on the GCAS portal, after which seats are allotted based on academic performance, choice of course, and reservation policies where applicable. The college does not entertain any form of direct or management quota admissions, upholding its commitment to fairness, transparency, and academic integrity.

Sports and Cultural Quota Admissions:

The college believes in nurturing talent beyond academics. The college proudly offers Sports and Cultural Quota admissions to recognize and encourage students who have excelled in extracurricular arenas. Reserved seats are allocated to students who have represented at district, state, national, or international levels in various sports or cultural activities such as music, dance, drama, fine arts, or literary competitions. Eligible students must present valid certificates and undergo a transparent selection process conducted by the college's admission committee.

This initiative reflects SSCCM's commitment to holistic development by providing equal opportunities to young achievers who bring glory to the institution through their outstanding talents in sports and culture. The college provides structured opportunities

in sports and cultural activities, ensuring holistic student development. These initiatives promote discipline, leadership, teamwork, and creativity, complementing academic excellence with all-round growth. 38 students in sports and cultural students have been given Rs. 2,83,150/- as a scholarship.

As a Peer Team Review Committee member evaluating the curriculum design of Swami Sahajanand College of Commerce & Management (Autonomous), it is commendable to observe a well-structured and academically enriched curriculum across all undergraduate programs. The curriculum demonstrates a thoughtful integration of traditional disciplinary foundations with contemporary, skill-based, and interdisciplinary courses. Each program, be it B.Com., B.B.A., B.C.A., or B.A. follows a balanced framework of core (Major), supporting (Minor), and enrichment (SEC, AEC, MDC, IKS, VAC) components, aligning with NEP 2020 goals and UGC guidelines.

The inclusion of field projects, internships, and multi-semester research projects indicates a strong emphasis on experiential and project-based learning. The integration of subjects like 'Financial Modelling', 'FinTech and Digital Finance', 'Web Development with AI', 'Film Studies', 'Gender Studies', and 'Indic Knowledge Systems' reflects an effort to maintain both global relevance and local ethos. The presence of skill enhancement courses (Career Skills, Leadership Skills, Communication Skills, and Life Skills) alongside value-added courses such as 'Osho's Philosophy of Life & Yoga' further strengthens the holistic and humanistic approach of the curriculum. The use of interdisciplinary minor options (like Data-Driven Economics and English 4.0) and flexible electives enhances student choice, employability, and academic breadth.

Overall, the curriculum stands out for its coherence, inclusivity, forward-looking orientation, and deep integration of knowledge, skills, values, and research making it robust for 21st-century higher education.

Examination & Evaluation Reforms:

The college has established an independent Examination Cell with structured policies and confidentiality. Dr. Neena Parekh, a senior Assistant Professor is in charge of Controller of Examination. Continuous and Comprehensive Evaluation (CCE) is in place, with multiple modes of assessment like assignments, tests, presentations, quizzes, and projects, open book exam etc.

Timely conduct and declaration of results have been ensured. The result of the first and second semester has been declared within 72 hours after the completion of the exam. The paper setting and evaluation is done through transparent and as per the norms.

Academic Performance:

The college has maintained an impressive academic track record under autonomy. The introduction of continuous internal assessment and structured evaluation under autonomy has led to better academic outcomes and student preparedness.

The external peer team, upon reviewing the result analysis of Semester I examinations for SEE-October 2024 and Semester-II for SEE-March 2025, observes a consistent upward academic trend across most programmes. Undergraduate programmes such as B.B.A. and B.Com. demonstrated significant improvement in performance, with B.B.A. results increasing from 75.14% to 87.27% and B.Com. from 65.65% to 77.42%. Similarly, in the arts programmes, subjects like Sociology, Psychology, and English reflected high pass percentages, indicating both effective teaching-learning practices and student engagement. The peer team notes that very low pass percentages in select courses may affect the overall academic reputation unless timely corrective measures are undertaken. The variability between October 2024 and March 2025 results, though improved in the latter, indicates that sustained effort is required to maintain consistency rather than short-term gains.

Infrastructure and Resource Mobilization:

The infrastructure supports autonomy with majority of the smart classrooms, a dedicated library, IT support, and academic spaces. Efforts have been made to mobilize funds through alumni, industry partnerships, and research initiatives.

Student Support & Holistic Development:

Student support services such as mentorship, career guidance, health & wellness initiatives, and a human library are commendable. Co-curricular and extension activities like NSS, SE & OP, SPARK, and Unnat Bharat Abhiyan have been effectively implemented.

At SSCCM, Google Classroom has been effectively integrated as a key digital learning platform to complement traditional teaching methods. This cloud-based tool enables faculty to create, distribute, and assess assignments seamlessly while fostering a collaborative and interactive learning environment. Students benefit from 24/7 access to study materials, recorded lectures, class notes, and announcements enhancing flexibility and self-paced learning.

The platform also encourages student participation through discussion threads, instant feedback, and real-time query resolution. Its structured interface has promoted better organization of academic content, increased student accountability, and improved faculty-student communication. Overall, the adoption of Google Classroom has significantly enriched the teaching-learning experience, aligning with the college's commitment to digital excellence and academic innovation.

Outcome-Based Education (OBE) & Graduate Attributes:

All the programmes have been mapped with Programme Outcomes (POs), Course Outcomes (COs), and Learning Outcomes (LOs).

Quality Assurance & Long-Term Vision:

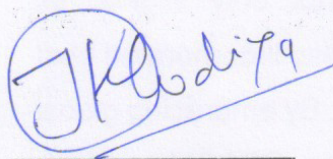
